



## FITTING INSTRUCTIONS FOR LP0055BK LICENCE PLATE HOLDER YAMAHA DT125R AND DT125X 2007



**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

- Remove seat.
- Remove rear cowling.
- Remove OEM licence plate holder.
- Remove OEM indicators from licence plate holder if they are to be re-used.
- If fitting after-market mini indicators try R&G mini-indicators (product code RG370).
- If not already fitted, fit new number plate light to R&G licence plate holder.
- Fit OEM or after-market indicators to R&G licence plate holder.
- Offer up new licence plate holder to original mounting points (feeding wires through as original) and using OEM bolts secure and tighten R&G licence plate holder.
- Connect indicators and number plate light (**suggest cutting connector from OEM unit and splicing to R&G unit using connectors supplied**).
- Refit rear cowling.
- Refit seat.
- Depending on local laws, attach enclosed red reflective tape in an appropriate location.
- Test the indicators and licence plate illuminator before riding.

All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
